Forum Purpose (s):

Overarching Purpose: The FORUM is intended to provide an annual process for information sharing and discussion on Fraser salmon fisheries issues between DFO and First Nations (Tier 2) and First Nations with other First Nations (Tier 1).

March FORUM Purpose: The intent of this meeting is provide an overview of the contents of the draft 2014/2015 IFMP for southern BC salmon and to initiate thinking about fishery planning for 2015. There will also be a presentation from the Province on the Draft Steelhead Management Framework.
