

# Thompson and Chilcotin Steelhead SARA Emergency Listing Process

- SARA Listing package was submitted to DFO Ottawa from DFO Pacific Region in December 2018
- Imminent threat opinion not yet provided by MECCC.

→ If no imminent threat – exits the Emergency Listing Process

- It is VERY UNCERTAIN when a Listing Decision (if required) will be made. Currently, we anticipate a decision from GIC (Cabinet) in Spring 2019.

# 2019 Fisheries Management Linkages to T&C Steelhead

- The timing of the Potential Listing Decision for T&C Steelhead overlaps with the 2019 IFMP development and approval period
- Because of this overlap, the 2019 South Coast Salmon IFMP will contain two distinct management options for most South Coast salmon fisheries
- These are:
  - **DO NOT LIST Scenario** similar to 2018 measures
  - **LIST Scenario** based on the SARA consultation package

# DO NOT LIST Scenario

The DO NOT LIST Scenario describes management measures that will be taken in 2019 fisheries if:

- T&C Steelhead are not listed under SARA OR
- if a Listing Decision has not been made prior to the initiation of fisheries

The 2019 steelhead management measures under this scenario will be based on 2018 measures:

- Approx. 27 day window closure for in-river commercial, in-river recreational, and Johnstone Strait gillnets (may require additional science advice concerning duration of closure period)
- Reduced fishing time for salmon FSC gillnets in-river
- Minor modifications to this approach may be considered if alternative, but equally effective, conservation measures are identified during consultations

	Johnstone Strait Chum Troll (Area H)	status quo - open for Chum

	Nitinat Chum Purse Seine (Area B)	status quo - closed until October 14
	Fraser Gillnet (Area E and FN EO)	no fishing in window closure; closure starts between Sept 28 and October 3 depending on area

# LIST Scenario

The LIST Scenario describes management measures that will be taken in 2019 if T&C Steelhead are listed under SARA prior to the initiation of fisheries

- SARA listing will trigger automatic prohibitions: kill, harm, harass, capture, take, possess, collect, buy, sell or trade
- Because allowable harm is so small for these populations (based on Recovery Potential Assessment), exceptions to these prohibitions are anticipated only for scientific activities
- Fishery closures will be identified for all sectors and gears in those times and areas where T&C Steelhead may be intercepted. This includes both the east and west coast of Vancouver Island.

# LIST Scenario

- Minimum 60 day window closure period, which may be extended based on Science Advice contained in Recovery Potential Assessment (see handout for area specific dates)
  - Closures in north Vancouver Island to start no later than August 22nd
  - Closures at the Fraser River Mouth to start no later than Sept 11
- Terminal fisheries which do not occur within migratory route for T&C Steelhead will be permitted. Details of these terminal fisheries will be described in the IFMP. Details of terminal FSC fisheries will be developed with local First Nations.
- Trickle down effects to fisheries not directly impacted by closures may be considered (e.g. more fishing may occur in remaining terminal fisheries if broad closures are implemented)
- Kelt outmigration period – actions expected in the future as additional information becomes available

# 2019 South Coast Salmon IFMP

- All fisheries occurring within the LIST Scenario closure period and areas will have associated SARA LIST management measures identified in the draft 2019 IFMP
- These measures will only be implemented if T&C Steelhead are listed under SARA prior to the initiation of fisheries in 2019
- If T&C Steelhead are not listed under SARA prior to the initiation of fisheries in 2019, the DO NOT LIST measures will be implemented
- Both LIST and DO NOT LIST Scenarios will be included in the draft IFMP (Feb 22) for review and feedback
