

## Forum on Conservation & Harvest Planning for Fraser Salmon

### **Forum Purpose (s):**

**Overarching Purpose:** The FORUM is intended to provide an annual process for information sharing and discussion on Fraser salmon fisheries issues between DFO and First Nations (Tier 2) and First Nations with other First Nations (Tier 1). First Nation attendees have the opportunity to provide their advice and recommendations on management plans.

**March FORUM Purpose:** The intent of this meeting is provide an overview of the contents of the draft 2017/2018 IFMP for southern BC salmon and to initiate thinking about fishery planning for 2017.

The information is provided to improve our understanding of Fraser Sockeye population dynamics.*


