- The agenda was accepted as presented.

3. Southern BC Chinook Strategic Planning Initiative (CSPI) Update

- Currently bringing together information on 35-36 southern BC Chinook CUs, and preparing a template.
- Planning a status workshop in February, and a Chinook science workshop to be funded by the PSC Southern Endowment Fund.
- Planning a CSAP process review for pre-COSEWIC status assessment of Chinook
- Considering a new tool for Chinook management (similar to FRSSI process).
- Working on an RFP for a process facilitator.
- Need to clarify role of FRAFS in the CSPI process.

4. JTWG: a) TORs as brought forward to the EC by the co-chairs; and b) chum salmon management issue

- The JTWG Co-Chairs presented a new JTWG TOR at the last EC meeting. The EC agreed to accept the new TOR.

MOTION #1 – To accept the new Terms of Reference for the Joint Technical Working Group.

- Discussed JTWG involvement in chum management issues. There is interest in the Lower Fraser in getting the JTWG more involved, but time and human/financial resources are limited. The LFFA and JTWG co-chairs will work on some options for chum discussions, to be presented to the EC at the next meeting.
