

The Nicola People Say 'Thank You'

K^wuk^wscémx^w, Thank you! Two small words that mean so much for the future.

After the dismal lack of fish in 2009, I didn't think that requesting help would get very far. Our people are so hungry, how can we ask them to not fish in 2010 for the first ones that come back after winter? To stand on the shore and watch others go out fishing for the very fish we were asking to protect.

We asked for this help for the future generations: of people, of Chinook. We showed the depressing numbers of returns for 2009: Spius Creek, 138, Coldwater River, 26 and the Nicola River, 461. Our neighbors in the Secwepemc had lower numbers than us.

We asked and the marine and lower river First Nations (including those under treaty) all agreed or supported the Moratorium that was placed during the migration timing of the Earliest Timed Chinook, also known as the 4(2).

The result of the moratorium comes in the form of the following numbers for the Nicola:

The return did better than brood for the Nicola River, but not for Spius Creek or Coldwater River without the moratorium it would have been devastating for those two streams.

Nicola did better than brood; does that mean we are ok? Unfortunately, no, but where do we go from here? The first goal for the Nicola system is to reach our escapement

targets: 2000 Chinook in the Spius Creek, 2000 Chinook in the Coldwater River and 6000 Chinook for the Nicola River.

In reality we need even more than that to feed the people from the marine up to the spawning grounds, more for the other 137 species that rely on the salmon (Information from Salmon Nation poster) including the Orca's, more for the eco-system. But we can only take one step at a time.

The unity of the First Nations from the marine to the spawning grounds showed us that we could make an impact to re-build our stocks. How do we continue without impacting our own rights to fish? How do we continue to re-build without losing more of our traditional fishing timing? These are questions to be answered this winter and into 2011 spring.

Until then, our hands are held up, in honour and respect to all lower river and marine people. Thank you for showing support and unity to protect some of our many stocks of concern. We must continue to ask for this help for the next four to eight years, but with unity we will do this without impacting our own rights and will become accountable for our actions to the next seven generations.
